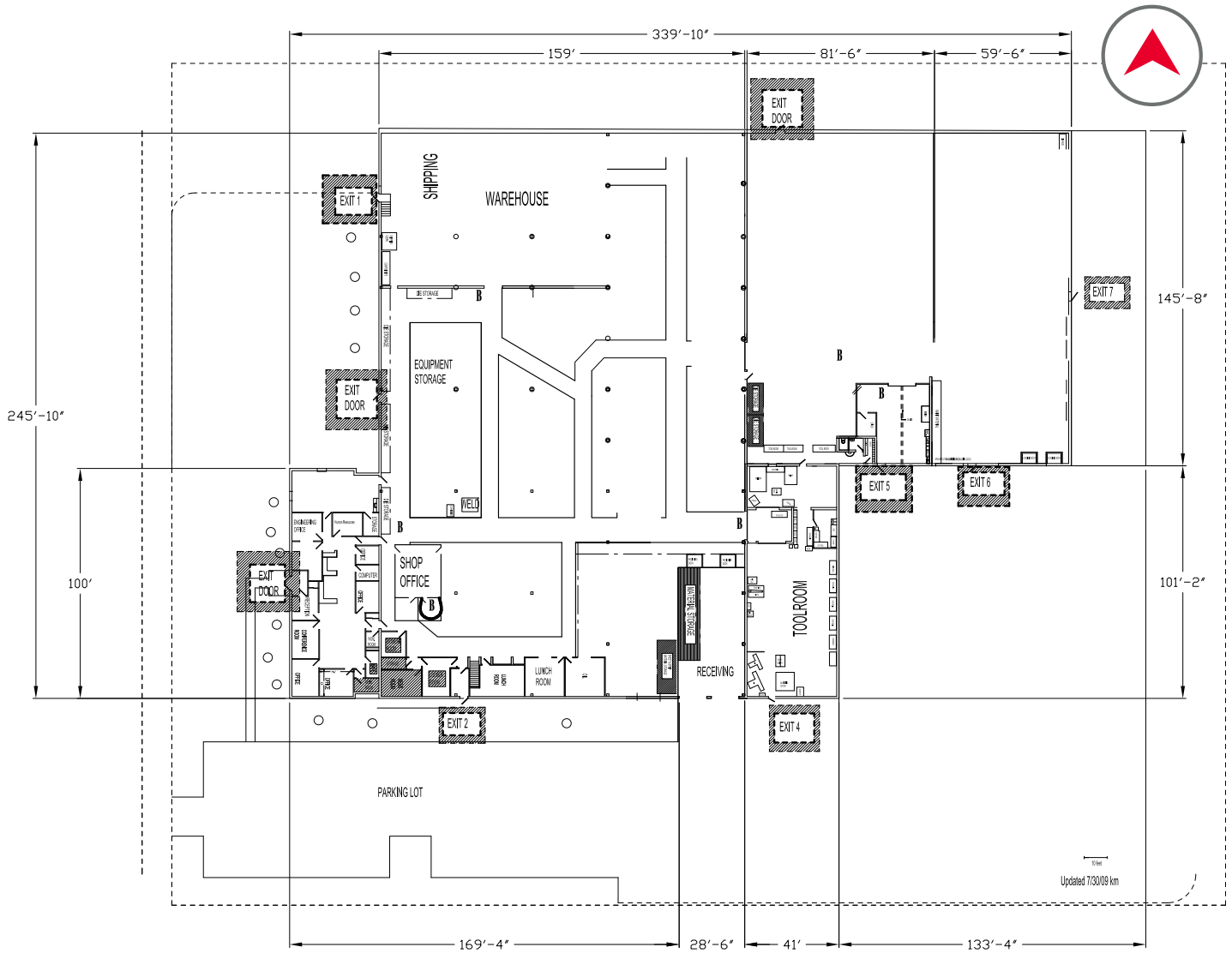

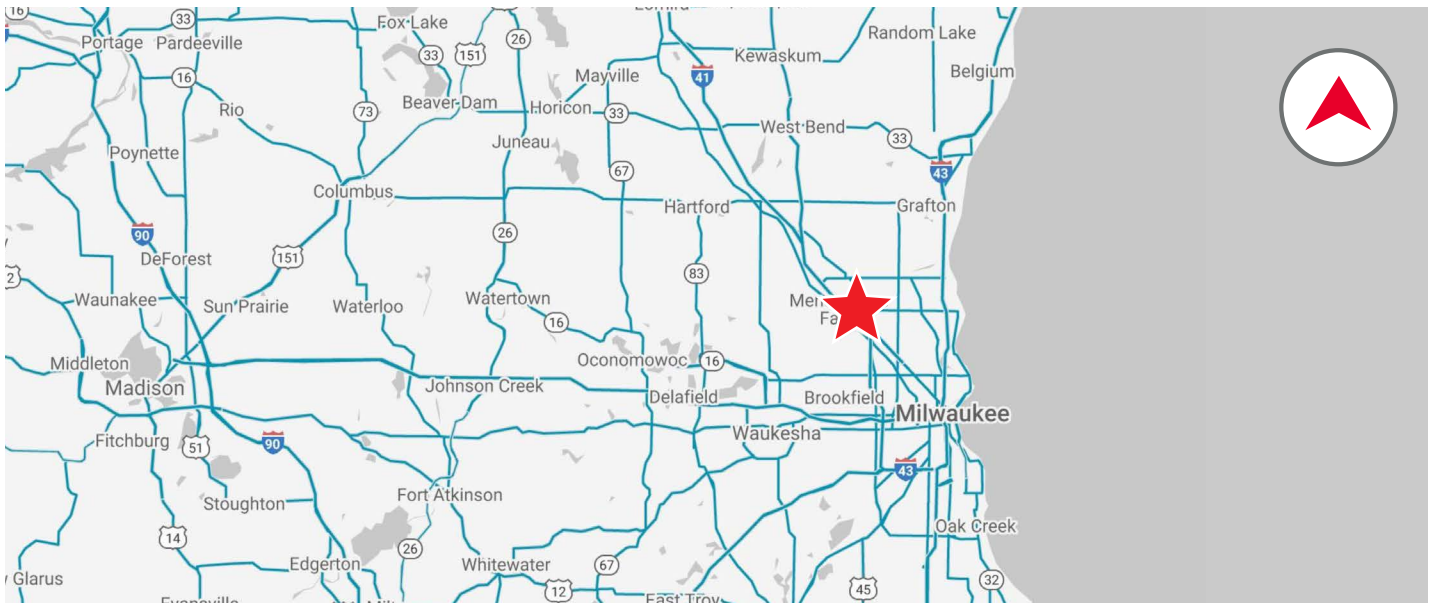

DEFINITION OF MATERIAL ADVERSE FACTS
